

# **Supplemental Conditions of Contest: SBU Senior Camrose Trial**

# Season 2012-2013

Version 1 – 20th November 2012

#### 1 Overview

- 1.1 The SBU Senior Camrose Trial relates to the selection of the SBU team for the 2013 Senior Camrose Trophy.
- 1.2 The 2012-2013 trial process will consist of one weekend December 15<sup>th</sup> and 16<sup>th</sup> 2012
- 1.3 The leading two pairs from the weekend will each be selected for the Senior Camrose in Wales on May 17-19 2013.
- 1.4 The Selection Committee will select the 3<sup>rd</sup> pair from those who finished in the top half of the field.

## 2 Authority

2.1 These Conditions of Contest are supplemental to the General Conditions of Contest and are established by the Selection Committee ("Committee") of the Scottish Bridge Union.

#### 3 Entries

3.1 The entry fee for each weekend of trials is £40 per pair. This covers coffee/tea throughout but not meals. Food will be available to purchase.

#### 4 Dates

4.1 The Trial will be held on December 15 & 16 2012 at Stirling BC.

#### 5 Event Format

5.1 The Trial will take place over a single weekend. Each pair will play 10 boards against all other pairs. Scoring will be by cross-imps with a cap and a floor. The cap will be the minimum number of imps required for a 25 VP win had the relevant international VP scale been used, and the floor will be the minimum number of negative imps required for a zero VP loss. These results will be published board by board and as totals. There will also be, for information only, a conversion of the total imps by a mathematical factor to give totals which can be more easily related to a head-to-head match format.

#### 6 Fines

6.1 Any fines levied by the TD will be expressed in x-imps using conversion guidelines as shown in the EBU White Book, and will be applied after capping (in the absence of clear cause to the contrary).

### 7 Appeals Process

7.1 An appeals panel duly constituted will consider any appeals.

- 7.2 Any pair wishing to make an appeal against a TD ruling should consult a neutral advisor prior to lodging their appeal. A list of names and telephone numbers will be available at each weekend.
- 7.3 A deposit of £30 will be required if an appeal is made; this may not be refunded if the appeal is deemed to be without foundation (frivolous).

#### 8 Communications

- 8.2 Email is the preferred means of communication, but communications and attachments (notably systems) sent by email will not be taken to have been received by the Committee unless acknowledged.

The result of the trial will provide input to the Selectors regarding their choice of the third pair for Bali. However the only undertaking given in respect of that choice is that it will be made after consultation with the five team-members already chosen.
