

## Senior European Trial for 2022 – Supplementary Conditions of Contest

The trial for the Senior European team will take place on Realbridge the weekend of January 15<sup>th</sup> & 16<sup>th</sup> 2022. The leading 8 pairs of Seniors from the recent Senior Camrose trial who wish to be considered for the Senior European team are invited to participate. These are -

The **'Carry Forward'** beside each pair represents 31% of the total scores against all the pairs who participated in the Senior Camrose/Lady Milne trial. Using 31% of your existing score allows both weekends to be of approximately equal weight.

Should any pair no longer wish to participate, please let me know immediately so a reserve pair can be offered your place.

The trial will be organised as a Full Howell so that each pair plays every other pair. Each match will be of 14 boards with 112 mins (8 mins per board) allocated. Time penalties will be applied for over-running matches unless caused by technical issues. The decision on this is in the remit of the TD.

**Video and microphones are required to be turned on at all times during play.**

The scores for each match will be in X imps with a cap appropriate to the number of pairs and boards played – **this will be 140.**

The top 2 pairs will automatically be selected for the Senior European team. The choice of the 3<sup>rd</sup> pair will be up to the International Committee using information available from the trial and in consultation with the top 2 pairs.
